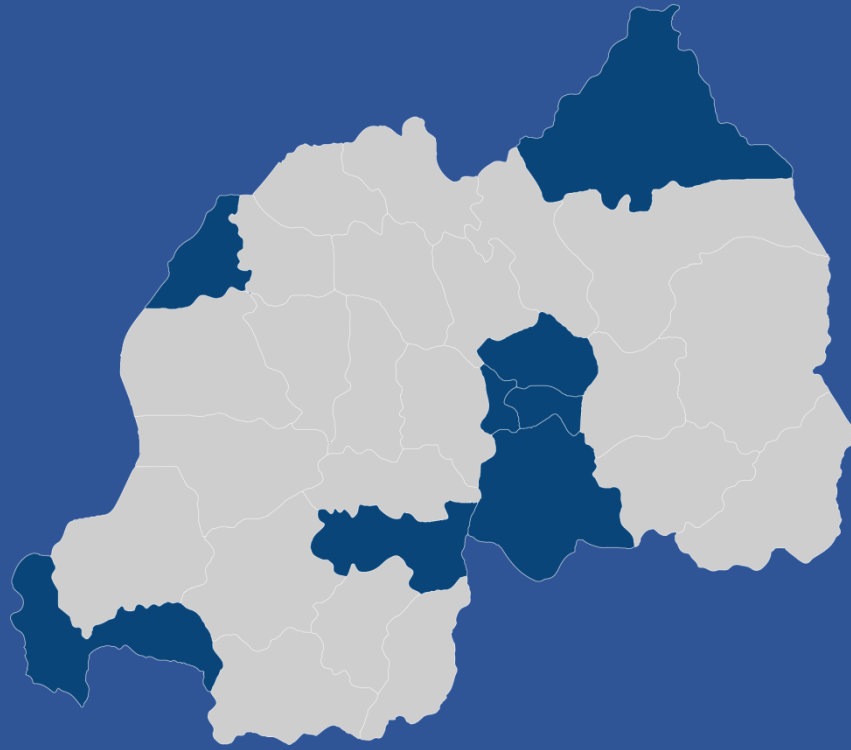

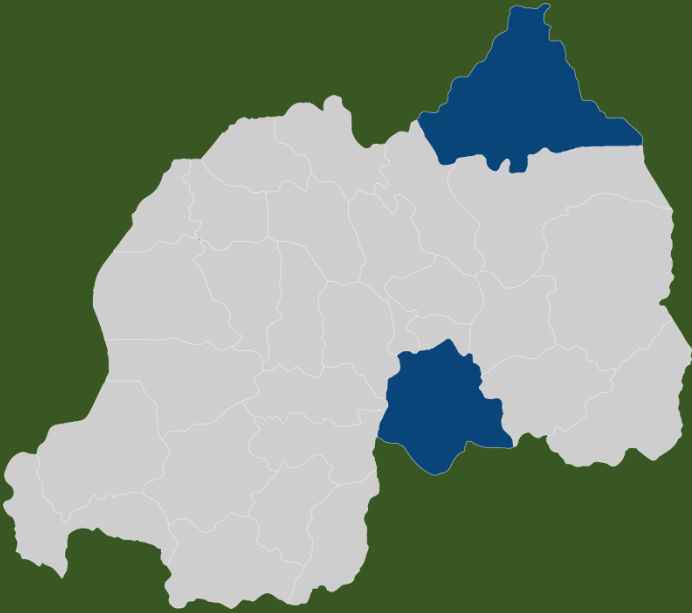
- Enhanced farmers' access to improved Agri inputs (seeds and fertilisers);

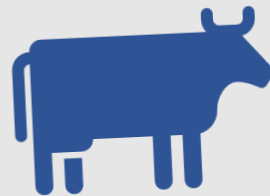

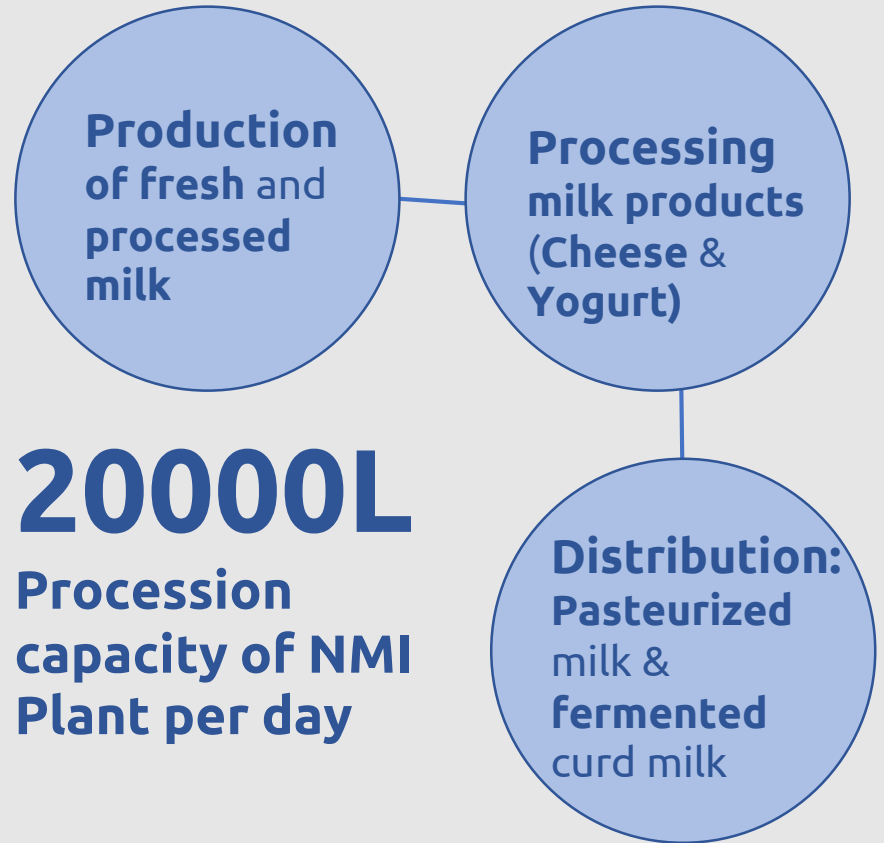

APTC Projects: GAKO Livestock Farm

- Early 2015, APTC introduced Gako flagship project to **increase quality meat production** for local and export markets;
- The project was established to support the supply chain of meat to Rugari Meat Processing Industries and serve as **a model farm for breeding and fattening of animals**;
- Animals reared at Gako farm are mainly cattle (1116) – (Boran, Sahiwal, Fleckvieh, Ankole, Charolaise) and goats (417)
- Management intends to **specialize in cattle, sheep and goat fattening**.

Objectives

- To exploit the full potential of Gako farm in order to ensure steady supply of live animals for slaughtering at Rugari abattoir
- Enhance organization and staff capacity for increased effectiveness and efficiency of Gako farm

APTC POULTRY FARMING

- APTC POULTRY Farm is a new project opened at Kanzenze, Bugesera District.

This project is owned by APTC since 31/10/2019.

- The farm has capacity to accommodate around 20,000 chickens.

Objectives

- Diversification of APTC production (meat & eggs) to enhance food security in terms of proteins

APTC Projects: Fertilizers and Seeds distribution

- Since July 2016, APTC started the distribution of inputs through Farmers Associations;
- These fertilizers include **AMIDAS, CEREAL, DAP, KCL/MOP, NITRABOR, NPK, TRACEL BZ, UREA and WINNER** that are used to cover maize, beans, soya, wheat, rice, Irish potato, cassava, banana and vegetables and fruits.

Objectives

To distribute various types of fertilizers to agro-dealers for onward delivery to farmers, collection of delivery notes and farmers' sales lists from agro-dealers
